EMERGENCY MEETING MINUTES: 08/30/2022**

An Emergency Meeting of the BOS was held on Tuesday, August 30, 2022. Meeting was held at Municipal Bldg., located at 169 Urban Rd, Hawley, PA 18428. No Notice required, but public was notified by Social Media, email and the internet. Let the record show that 4 residents attended the meeting.

Facts surrounding the reason for the Emergency meeting: Meeting was called to protect the property of the township, IE: Westcolang Road. The Westcolang Road was just finished being paved Friday, August 26, 2022. Our engineer states the road needs 7-10 days to naturally cure before heavy road trucks traverse the road. The state has presently shared with us that they will be using our road to move 73,000 lb. trucks on Westcolang against our wishes to transport aggregate to their Mast Hope Plank Road Project, essentially trying to force our residents to allow our Road to be destroyed so they can finish their project. They have refused to agree to our requests to avoid Westcolang by using detours during the curing process. This has caused an emergency within the township by causing undue damage to the recently finished Westcolang road which is the property of the township. The Board of Supervisors have no other choice but to reduce the weight limit on Westcolang Road during the curing process. The township will provide a detour route around Westcolang Road during this time.
